

休校期間중의 図書館 利用

本図書館에서는 非常事態로 인한 休校期間중에도 教授의 研究를 積極支援하기 위하여 正常的으로 業務를 遂行하고 있아 오니 많은 利用을 바랍니다.

名譽教授의 図書館資料 利用

本図書館은 名譽教授의 図書館資料利用을 위하여 図書館規定 제 10 조 1항을 改定하였다. 앞으로 名譽教授도 本規定에 依拠 現在職教授와 同等한 待遇를 하게 되었습니다.

藏書의 点檢

本図書館에서는 非常事態로 인한 休校期間중 各書庫와 一部 閱覽室内 藏書의 부분点檢 및 汚損図書索出作業등을 하고 있다. 이는 開架制로 運用되고 있는 定期刊行物書庫, 基本図書室, 參考閱覽室, 書誌室등 많은 利用者때문에 平常時에 實施하지 못했던 作業으로서 이번 休校期間동안에 完了할 豫定이다.

図書館 來訪

10月 9日에는 亞細亞太平洋地域開發研究 및 訓練協會 (ADIPA) 제 4차 總會에 참가한 태국의 Dr. Augustin Kintarnar 事務局長의 18個國 會員 133명이 來訪하였다.

10月 12日에는 英國図書館委員會 議長이며 Sheffield 大學 總長인 Fredrick Sidney Dainton 博士 内外분이 來訪하였다.

目錄業務의 電算化를 위한 試驗的 研究

本圖書館에서는 目錄業務의 電算化에 대한 試驗的 研究를 하기로 하고 本校 電子計算所의 協助 아래 入力시킬 目錄에 대한 Worksheet의 樣式을 調整하며 作成中이다. 이는 지난 8月28日 來韓한 美國 Denison大學 張採吉 教授를 中心으로 圖書館業務의 電算化에 대한 研究의 一環이다. 10月10日에는 「카나다」의 IDRC의 圖書館電算化專門家 (V. G. Jorssen)와 KIST의 資料室長이 來訪하여 本校 電子計算所長과 圖書館電算化를 위한 施設 導入計劃에 관하여 意見을 交換하였다. 11月7日에는 KIST의 電算化專門家와 資料室長을 招請하여 그간의 研究 実績을 土台로 그 妥當度를 높일 檢証에 대한 討議가 있었다.

이 研究는 約 500余種의 各種資料에 대한 目錄을 入力시켜 여러가지 形態로 원하는 情報의 出力을 試驗해 보는 것으로서 그 結果는 今年末頃에 나올 豫定이다.

本校教授 著書 蒐集

지금까지 本校 事務局 總務課에 保管중이던 教授任用手續過程에서 各教授가 提出한 研究 実績資料를 引受받아 保存管理 및 그 円滑한 活用을 圖謀하고 있다. 이번에 引受된 資料는 모두 4,208件으로 그중 本校 教授의 單行本, 論文集, 學術誌, 定期刊行物이 2,078件이고 其他 別刷本이 2,130件이다.

위 資料는 年1回씩 收合하여 圖書館에서 引受할 豫定이므로 當館은 이와 관련하여 別途로 假稱 大學文書室 (University Archives Room)을 마련하여 本資料들을 活用시키고 아울러 大學의 保存的 文書, 豫算書類 등 諸般 必要한 資料들을 備置할 豫定이다.

旧刊未登錄圖書의 整理

当館 6 층에 所藏하고 있는 11,600 冊의 旧刊未登錄 圖書
를 整理하여 活用케 할 豫定에 있다. 이 資料는 冠岳캠퍼
스에 圖書館綜合化할 當時 商大 및 法大등이 所藏하고 있던
未登錄된 旧藏書로서 大部分 旧帝時 蒐集된 古資料들 이다.
이번에 社會大의 金宗炫, 安乘直教授와 法大 黃迎仁教授 등의
考証을 받아 登錄 또는 廢棄豫定圖書를 選別하였는데 이들의
큰도움을 받았다.

圖書寄贈 서울國際郵遞局長

지난 10月 25日 서울國際郵遞局長이 当館에 Grundwissen
Deutsche Literatur (獨逸文學의 基礎知識) 등 123 冊을 寄贈
했다. 이 중에는 프랑스, 스위스語로 된 便覽등 基本圖書가
많이 包含되어 있는데 이들은 各界 人士들이 入國時 搬入
하던중 通関이 保留 또는 未引受한 것으로서 有効期間이
經過되어 当館에 寄贈하게 된 것이다. 이 紙面을 빌어 서울
國際郵遞局 當局에 대하여 깊은 謝意를 表하는 바이다.
앞으로 이러한 資料들이 繼續 寄贈되었으면 한다.
